Camp is limited to 24 students per week. The class will be split up with two Camp Counselors each taking 12 students each along with a volunteer/Jr. Camp Counselor to help.

Farm Camp is four days a week, Tuesdays – Fridays, from 9am-4pm. PLEASE NOTE: Week 3 is a 3-day session at a reduced cost. Campers should be picked up by 4pm. If a camper is not picked up by 4:10pm, a late fee of \$1 per minute will apply until they are picked up - fee to be paid at time of pick-up.

**COST/CANCELLATION POLICY:** Payment is due in full at the time of registration. All cancellations made prior to April 30th will be returned minus a \$50.00 administration fee for each camper/week/session cancelled. After May 1st, a 50% refund will be given. No refunds will be given for cancellations after 6/1 except for medical reasons (*physician note/letter must be provided*). All cancellation requests must be in writing to farmteam@mayburyfarm.org.

**Cost for 4-day Session: \$335** early registration. If *payment is received after 5/1/25, registration is \$360*

**Cost for 3-day Session (WEEK 3 only): \$260** early registration. If *payment is received after 5/1/25, registration is \$285*

Payment can be made safely online only. Camp registration form and the camper medical form must also be provided.

*PLEASE NOTE: Your child's reservation is not guaranteed until payment is made and the registration form has been received. We will also be checking to confirm that your camper is six by 3/31/2025 and that they have completed kindergarten within 24 hours of registering online. Please note if your child has ever been released for behavioral issues then cannot be registered for camp (per the CARE's Agreement that was signed previously).
